
Our legal processes and the monitoring and implementation of our environmental processes, along with our declaration and reporting obligations, are meticulously managed by our environmental consultants.






EMISSION MANAGEMENT

ENERGY MANAGEMENT

Energy consumption, aimed at continuous improvement in energy efficiency, is monitored and reviewed on daily, monthly, and yearly periods.

Each year, significant energy usage points are identified, and energy efficiency projects are prepared.

In addition to these efforts for existing facilities, new investments are evaluated in terms of energy efficiency, and reducing the specific energy intensity in products to be manufactured is targeted.

Alongside efforts to increase energy efficiency, feasibility studies related to the use of renewable energy are ongoing with the aim of reducing our carbon footprint in line with sustainable development goals and the process of aligning with the European Green Deal.

WATER MANAGEMENT

Our facilities are developing and implementing projects to reduce water consumption. Water consumption values are regularly monitored on a monthly basis, and water leakage checks are continuously carried out, ensuring the fastest possible intervention.

For a sustainable environment, we discharge water to the receiving environment with quality that complies with both the discharge limits we are subject to in the Water Pollution Control Regulation and international legislation and standards.





GENERAL WATER RISK

Our hotel is located in an area where all indicators selected from the categories of Physical Quantity, Quality, and Regulatory and Reputational Risk are collected to measure all water-related risks.

WASTE MANAGEMENT

Our processes prioritize the reduction, source separation, and reuse of waste generated within our facility by considering the product life cycle.

In our facility, hazardous and non-hazardous wastes are generated. The hazardous wastes are collected in a temporary storage area authorized by the Provincial Directorate of Environment, Urbanization, and Climate Change, and are sent to licensed facilities with licensed vehicles and drivers via the MOTAT (mobile waste tracking) system.

Non-hazardous wastes are also collected in a non-hazardous waste temporary storage area and delivered to licensed facilities. In managing these processes, our Environmental Consultant and an employee responsible for the waste area are involved.

Almost 100% of the hazardous and non-hazardous wastes generated in our facility, such as plastic, glass, paper-cardboard, metal, batteries, and oil, are recycled by licensed facilities.
